2019 River Valleys Unified School District Annual Meeting
February 12, 2019 at Wardsboro Town Hall at 7:00 p.m.**

The legal voters of the Towns of Dover & Wardsboro, Vermont are hereby notified and warned that, pursuant to Title 17, V.S.A., Section 2655, they are to meet at the Wardsboro Town Hall in Wardsboro, Vermont on Tuesday, February 12, 2019, at 7:00 p.m. to act upon the following articles to wit:

ARTICLES 9, 10, 11 & 12 TO BE VOTED BY AUSTRALIAN BALLOT AT TOWN MEETING IN DOVER & WARDBORO ON MARCH 5, 2019.

The polls will open for Australian ballot voting at 10:00 a.m. and remain open until 7:00 p.m. on Town Meeting Day, March 5, 2019 in Dover & Wardsboro.

- ARTICLE 1:**
- a. To elect a Moderator to serve for the fiscal year July 1, 2019 to June 30, 2020
 - b. To set a stipend of \$200 for the Moderator
- ARTICLE 2:**
- a. To elect a Clerk to serve for the fiscal year July 1, 2019 to June 30, 2020
 - b. To set a stipend of \$2,400 for the Clerk
- ARTICLE 3:**
- a. To elect a Treasurer to serve for the fiscal year July 1, 2019 to June 30, 2020
 - b. To set a stipend of \$2,400 for the Treasurer
- ARTICLE 4:**
- a. To elect 3 Auditors to serve for the fiscal year July 1, 2019 to June 30, 2020
 - b. To set a stipend of \$200 per Auditors
- ARTICLE 5:** Shall the voters of the River Valleys Unified School District set the annual stipend for School Directors at \$2,000 and for the Chair at \$2,500?
- ARTICLE 6:** Shall the voters of the River Valleys Unified School District set the annual tuition rate to approved independent schools at \$17,540 for the 2019-2020 school year?
- ARTICLE 7:** Shall the voters of the River Valleys Unified School District approve mileage reimbursement at the Federal reimbursement rate for the month in which the mileage occurred?

ARTICLE 8: Shall the voters of the River Valleys Unified School District authorize the School Directors to withdraw money from the Capital Reserve Fund to offset the Homestead tax rate, but not more than \$200,000?

Articles 9-12 to be voted by Australian ballot at Town Meeting in Dover and Wardsboro

ARTICLE 9: Shall the voters amend Article 13 of The Articles of Agreement striking the last two sentences of the first paragraph which will allow the Unified District to vote its annual budget from the floor at their Annual Meeting?

ARTICLE 10: Shall the voters change the method of voting for Board members in Wardsboro by amending Article 13 of The Articles of Agreement replacing the last paragraph with the following language: "Election of Unified District Board members shall be conducted by Austalian ballot in Dover and from the floor in Wardsboro with each town electorate choosing the Board members from their town"?

ARTICLE 11: Shall the voters of River Valleys Unified School District approve the school board to expend \$5,346,131 which is the amount the school board has determined to be necessary for the ensuing fiscal year?" It is estimated that this proposed budget, if approved, will result in education spending of \$17,678 per equalized pupil.

ARTICLE 12: To choose Unified School District officers for the following positions:


School Director (Wardsboro)	3-year term
School Director (Dover)	3-year term


ARTICLE 13: Any other business that may legally be addressed

- e. Any other concerns that may legally be discussed


ARTICLE 14: Shall the voters adjourn and reconvene at Dover and Wardsboro for Australian ballot voting on Town Meeting Day?


